Project and Schedule Update

At the May 24th meeting, the Steering Committee reviewed the draft plans for the needs analysis and community engagement and discussed preparations for Public Engagement Phase 1.

The Richmond Connects team is now beginning the computational needs analysis, and the public survey is now underway.

At the next Steering Committee meeting, scheduled for September 27th, the Committee will review the draft raw needs maps and survey responses.

Update on Public Engagement

Jessica Dimmick provided an update on the public engagement. Currently, we are in the middle of the first of five phases of public engagement for Richmond Connects. Information on the public engagement effort is provided in the meeting presentation. The Steering Committee reviewed the number of responses received to date, examples of what the responses are



saying, the events that the engagement team has participated in, demographic statistics of respondents, and plans for remaining engagements events in this first phase.

The Richmond Connects team requests that Committee members promote the survey through their communication and outreach channels through August 15th, at which point the team will incorporate the responses into the needs analysis.


The team also welcomes suggestions on specific neighborhoods, areas, or places where the outreach team should focus on door-to-door canvassing in the last weeks of this first phase of engagement.

The Richmond Connects team will have a table at two locations for National Night Out on Tuesday August 2, 2022 – the Satellite Restaurant in South Side and the Northside Outreach Center on Meadow Bridge Road. Amy Robins asked if there are small flyers that the Council office can hand out at the other National Night Out events that they will be attending. Chenice Brown will connect with Amy to provide flyers that are already printed.

Amy also asked the Richmond Connects team to reach out to The Virginia Home in Byrd Park. The Virginia Home is a long term care facility for people with irreversible disabilities. Many of the residents are senior citizens. They had reached out to request information. Amy asked the team to reach out to meet with them. Needs Analysis Update

Kelli Rowan provided a refresher on the needs analysis framework and walked through an illustrative hypothetical example of the bicycle needs analysis to demonstrate how the various individual simple metrics will be overlaid and combined to identify top tier needs. The ultimate outcome of the needs analysis will be 11 integrated needs maps – one for each Investment Need Category.



In the hypothetical example that Kelli showed, there were two areas that rose to the top as Tier 1 needs. In the actual needs maps, it is expected there will be many more than just two Tier 1 needs that arise.

The Committee discussed how the maps will be made available to the public. The Richmond Connects team is working on developing an interactive online platform for viewing the maps that allows the user to toggle various metrics on and off.



The Committee discussed how metrics will be revisited in future years to be able to see progress over time. The final Richmond Connects Plan could identify a shorter list of metrics to evaluate periodically in the future to track progress. This would be a shorter list of metrics than what the team is currently analyzing for the full needs assessment.

The Richmond Connects Scenario Plan will also provide information looking forward to the longer term future to anticipate what the transportation system performance would look like under different investment scenarios.
